Budget Revisions 2020

October 13, 2019

With the submission of the health care number from the Health Trust the budgetary adjustments required to the Board budget are below. This increase in health care costs was 12.5%, another double-digit increase. I have not received the back up data from Health Trust as of today but will provide it when it arrives. At this moment I will focus on the budgetary impacts.

The BOS budget that was passed carrying last years health number increased by under 1%, reflecting a budget that was truly level funded. In absorbing this increase that number will obviously go up, but the initial level funding leaves us, in the departmental budgets, with very little room to make additional cuts without cutting services.

With this increase the adjustment to the Board approved budget would be slightly over \$600,000, bringing the total increase to \$767,855, a 3.2% increase in the budget year to year. To further break that number down the non-contractual(discretionary) increase is limited to \$216,187, which is less than a

1% increase in your budget. Without cutting existing services it is simply not possible to make the budget any leaner.

It is our intent to put health care into one account in the next cycle, allowing us to measure departmental spending without regard to this number. This increase shows us exactly why that budgetary path is the correct one.




Group Specific Medical Rate Change History





You are hereby notified to meet in the auditorium of the Seabrook Community Center, U.S. Route 1 (Lafayette Road) on Tuesday, February4, 2020, at 7:00 o'clock in the evening to participate in the first session of the 2020Annual Town Meeting.

And, you are hereby notified that the polls will be open in the auditorium of the Seabrook Community Center, U.S. Route 1 (Lafayette Road) on Tuesday, March10, 2020, at 7:00 o'clock in the forenoon, and you may cast your ballots on the official ballot questions below, until at least 7:00 o'clock in the evening of the same day.

Further, you are notified that the Moderator will process the absentee ballots beginning at 1:00 o'clock in the afternoon on Tuesday, March 10, 2020, pursuant to RSA 659:49.

ARTICLE1

To select by non-partisan ballot:

- one (1) Selectman and Assessor for a term of three (3) years;
- two (2) members of the Planning Board for a term of three (3) years;
- one (1) member of the Planning Board for a term of one (1) year;
- two(2) members of the Budget Committee for a term of three (3) years;
- one (1) Trustee of the Library for a term of three (3) years;
- one (1) Trustee of the Trust Funds for a term of three (3) years;
- three (3) Constables for a term of one (1) year;
- one (1) Supervisor of the Checklist for a term of six (6) years;
- one (1) Moderator for a term of two (2) years

To see if the Town will vote approve the cost items included in the collective bargaining agreement reached between the Board of Selectmen and the Seabrook Employees Association for the period April 1, 20 through March 31, 20; and furthermore to raise and appropriate the sum of Dollars (\$) for fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at current staffing levels. The increases in salaries and benefits for fiscal year 20 would be \$. The increases in salaries and benefits for 20 would be \$ through March 31, 2021. (Majority vote required) (Recommended/Not Recommendedby the Board of Selectmen) (Recommended/Not Recommendedby the Budget Committee) (Estimated \$ impact per \$1,000 on the tax rate).

ARTICLE 7

To see if the Town will vote to approve the cost items included in the collective bargaining agreement reached between the Board of Selectmen and the Seabrook Police Association for the period April 1, 20 through March 31, 20; and furthermore to raise and appropriate the sum of Dollars (\$) for fiscal year 20, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at current staffing levels. The increases in salaries and benefits for fiscal year 20 would be \$. The increases in salaries and benefits for fiscal year 20 would be \$ through March 31, 20. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommendedby the Budget Committee) (Estimated \$ impact per \$1,000 on the tax rate).

To see if the Town, if any of articles 9 - 12 are defeated, will authorize the Board of Selectmen to call one special meeting, at its option, to address the relevant article's or articles' cost items only? (Majority vote required).

ARTICLE 9

To see if the Town will vote to establish an Information Technology Equipment Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of purchasing information technology capital items and to further name the Board of Selectmen as agents to expend. (Majority vote required).

NOTE: The creation of capital reserve funds will help to plan and save for larger future expenditures thereby smoothing the year-to-year tax burden on Seabrook taxpayers.

ARTICLE 10

To see if the Town will vote to raise and appropriate the sum of Forty-Thousand Dollars (\$40,000) to be added to the existing Town Building Capital Reserve Fund previously established? This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate.)

NOTE: This article would fund capital projects for each Town building.

ARTICLE 11

To see if the Town will vote to raise and appropriate the sum of Fifty-Thousand Dollars (\$50,000) to be added to the existing DPW Vehicle Capital Reserve Fund previously established? This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate.)

NOTE: This article would fund DPW vehicles on a scheduled replacement basis.

ARTICLE12

To see if the Town will vote to raise and appropriate the sum of Three-Hundred ThousandDollars (\$300,000) for improvements to Town streets consisting of pavement overlays, adjustments to associated structures, crack-sealing repairs, and design of drainage improvements. Said appropriation will be offset by a State Highway Block Grant estimated to be One Hundred Sixty Thousand Eight Hundred Dollars (\$160,800), and by a transfer of the sum of Eighty Thousand Dollars (\$80,000) from the Transportation Improvement Special Revenue Fund and an appropriation of Fifty Nine Thousand Two Hundred Dollars (\$59,200) from local taxation. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the projects are completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommendedby the Board of Selectmen) (Recommended/Not Recommended/Not Recommendedby the Budget Committee) (No tax impact on the tax rate).

NOTE: This article is included in the capital improvement plan that was submitted to the planning board.

ARTICLE13

To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000) for the purpose of cleaning, rehabilitation and long-term well and equipment maintenance for seven (7) bedrock wells and five (5) gravel pack wells. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended by the Board of Selectmen) (Recommended by the Budget Committee) (Estimated \$xxxximpact per \$1,000 on the tax rate).

NOTE: This article is included in the capital improvement plan submitted to the planning board. These wells provide the Town its drinking water. This work is required to prevent permanent damage to these wells and to maintain maximum pumping capacity.

ARTICLE 14

To see if the Town will vote to raise and appropriate the sum of One Hundred Forty-Three Thousand Seven Hundred Twenty-Seven Dollars (\$143,727) to construct new wells including well design, construction and infrastructure to connect to the water treatment plant. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in five (2) years (December 31, 2021), whichever occurs first. This is a special warrant article and authorizes the withdrawal of One Hundred Forty-Three Thousand Seven Hundred Twenty-Seven Dollars (\$143,727) from the water resources capital reserve fund created for that purpose, to fund the appropriation. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$0.00 impact per \$1,000 on the tax rate).

NOTE: This article is included in the capital improvement plan submitted to the planning board. \$725,000 was authorized with the 2015 warrant article #36 for two years and reauthorized in 2018 by article #17. The two years has passed and \$143,727 remains from the original article. The project is on-going and the funds need to be reauthorized to continue the work as described.

ARTICLE 15

To see if the Town will vote to raise and appropriate the sum of One Hundred Thousand Dollars (\$100,000) to repair and replace the Centennial pump station. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate).

NOTE: This pump station has had serious odor control issues for many years. This will be a comprehensive solution.

To see if the Town will vote to raise and appropriate the sum of Ninety-Four Thousand Dollars (\$94,000) for the purpose of upgrading the System Control and Data Acquisition (S.C.A.D.A.) system at the Town Wastewater Department. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate.)

Note: This article is included in the capital improvement plan approved by the Planning Board. These systems are twenty years old. The Programable Logic Controller (P.L.C.)the heart of the SCADA system, are no longer manufactured or supported by the factory. Without these components the automation would cease to exist.

ARTICLE 17

To see if the Town will vote to raise and appropriate the sum of Thirty-Five Thousand Dollars (\$35,000) to repair and replace the DPW pump stations and storm-water pump stations. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended /Not Recommended by the Board of Selectmen) (Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate).

ARTICLE 18

To see if the Town will vote to raise and appropriate the sum of Forty Eight Thousand Dollars (\$48,000) to replace the Town fuel pumps. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate).

ARTICLE 19

To see if the Town will authorize the Board of Selectmen to enter into a five-year lease/purchase agreement in the amount of Eight Hundred Seventy Five Thousand Dollars (\$875,000) for the acquisition and equipping of a modern Fire Rescue Truck for the Fire Department, and to raise and appropriate the sum of One Hundred Seventy Five Thousand Dollars (\$175,000) for the first year's payment for that purpose. This lease/purchase agreement contains an escape clause. Further, to authorize the sale or trade of the existing 2003 Rescue Vehicle. This will be a non-lapsing appropriation per RSA 32:7, VI and shall not lapse until the vehicle is fully owned or in five (5) years, whichever occurs first. In future years the lease payments will be included in the proposed and default budgets. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$ impact per \$1,000 on the tax rate.)

NOTE: This article is included in the Capital Improvement Plan approved by the Planning Board. This would be replacing a 2003 Rescue Truck. This truck is necessary to carry specialized tools to vehicle accidents and other emergency calls. This item is also in the CIP submitted to the Planning Board.

To see if the Town will vote to create four (4) new full-time firefighter positions within the Fire Department, and to raise and appropriate the sum of One Hundred Sixty Four Thousand Eight Hundred Forty Eight Dollars (\$164,848) in salary and benefits to fund these positions. If approved the appropriations for these positions will become part of the annual operating budget in subsequent years. (Majority Vote Required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) Estimated xxxx impact per thousand on the Tax Rate)

Note: The hiring of these four (4) firefighters in 2020 will only be for 4 -months. In subsequent years it will be for 12 months for a cost of \$498,748.

ARTICLE21

To see if the Town will vote to raise and appropriate the sum of Fifty-Thousand Dollars (\$50,000) to purchase and replace the radio communications equipment within the EOC office of the Fire Department, along with an exterior enclosure to house radios. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee).

NOTE: This article is included in the Capital Improvement Plan approved by the Planning Board. The EOC radios are almost twenty years old and are in need of an upgrade. This upgrade would also improve communication and redundancy with Police and Fire radio communications.

ARTICLE22

To see if the Town will vote to raise and appropriate the sum of One-Hundred Thousand Dollars (\$100,000) for the renovation of the locker room at the Police Station. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This sum to come from the unassignedfund balance. This is a special warrant article. (Majority vote required) (Recommended /Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (No tax impact on the tax rate).

NOTE: This article is included in the Capital Improvement Plan approved by the Planning Board. The current room is in the original form from the mid 1980's and has fallen into disrepair and has become unserviceable and unhealthy.

To see if the Town will vote to raise and appropriate the sum of Thirty-Five Thousand Dollars (\$35,000) to be added to the existing Police Department Equipment Capital Reserve Fund previously established? This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$ impact per \$1,000 on the tax rate.)

NOTE: This article would allow the Town to begin saving for the purchase of police equipment, due in 2025. The equipment will include replacement of firearms, tasers, protective vests, and digital equipment for cruisers. The combined cost is estimated at \$205,000.

ARTICLE 24

To see if the Town will vote to create two (2) new full-time patrolman positions within the Police Department, beginning in December of 2020, and to raise and appropriate the sum of \$25,644 in salary and benefits to fund these positions. If approved the appropriations for these positions will become part of the annual operating budget in subsequent years. (Majority Vote Required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) Estimated xxxx impact per thousand on the Tax Rate)

Note: The hiring of these two (2) Patrolman in 2020 will only be for 1-month. In subsequent years it will be for 12 months for a cost of \$225,204.

ARTICLE 25

To see if the Town will vote to raise and appropriate the sum of Forty-Thousand Dollars (\$40,000) to be added to the existing Fire Department Self Contained Breathing Apparatus (SCBA) and Turnout Gear Capital Reserve Fund previously established? This is a special warrant article. (Majority vote required) (Recommended by the Board of Selectmen) (Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate.)

NOTE: This article is included in the Capital Improvement Plan approved by the Planning Board. This article would allow the Town to begin saving for the mandatory purchase of turnout gear for Firefighters, estimated to be due in 2021, and mandatory purchase of SCBA breathing equipment, estimated to be due in 2025. The combined cost is estimated at \$280,000.

ARTICLE 26

To see if the Town will vote to raise and appropriate the sum of Seventy-Five Thousand Dollars (\$75,000) to install a wet sprinkler system at the Department of Public Works building. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate).

To see if the Town will vote to raise and appropriate the sum of One Hundred Fifty Thousand Dollars (\$150,000) for the purchase and equipping of a 6-wheel dump truck with plow and sander and further to authorize the sale or trade of the existing 2007 International Dump Truck with plow and sander. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the vehicle is acquired or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxx impact per \$1,000 on the tax rate).

NOTE: This article is included in the Capital Improvement Plan approved by the Planning Board.

ARTICLE 28

To see if the Town will vote to raise and appropriate the sum of Fifteen-Thousand Dollars (\$15,000) to construct a new pavilion behind the Recreation Center. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate).

NOTE: The participation number for the Summer Day Camp continues to increase year to year. This pavilion would provide extra space and recreational opportunities for the Summer Camp, as well as providing recreational opportunities for the rest of the year.

ARTICLE 29

To see if the Town will vote to raise and appropriate the sum of Fifteen Thousand Dollars (\$15,000) to repair and refurbish the concession stand at Governor Weare Park. This will be a non-lapsing appropriation per RSA 32:7, VI and will not lapse until the project is completed or in two (2) years (December 31, 2021), whichever occurs first. This is a special warrant article. (Majority vote required) (Recommended/Not Recommended by the Board of Selectmen) (Recommended/Not Recommended by the Budget Committee) (Estimated \$xxxx impact per \$1,000 on the tax rate).

NOTE: The concession stand is in need of repair.

Shall the town modify the Service-Connected Total Disability Tax Credit in accordance with RSA 72:35, II from its current tax credit of \$2,000 per year to \$4,000 per year? (Majority vote required).

Shall the town modify the Veteran's Tax Credit in accordance with RSA 72:28, II from its current tax credit of \$500 per year to \$750 per year? (Majority vote required)

ARTICLE33

To see if the Town will vote to raise and appropriate the sum of Forty- Five Hundred Dollars (\$4,500) for Wayfair Child & Family Services, a human service organization for the purpose of providing a range of home and community-based family support and counseling programs designed to tackle problems before they reach a crisis and provides treatment during a crisis to stabilize the family. This is a special warrant article. (Majority vote required) (Recommended/Not Recommendedby the Board of Selectmen) (Recommended/Not Recommendedby the Budget Committee) (Estimated \$ impact per \$1,000 on the tax rate).

ARTICLE 34
