

REFUND: There were a series of events, which caused this account to be overbilled. They had a leak that started in October 2019 and wasn't discovered and repaired until February 11, 2020, which is also around the time the meter failed and had to be replaced. At some time, in November 2019, they started a water conservation program, that should have reduced the usage, but the estimated billing was done on the prior year's usage, as has been done in the past. The average usage for the past four months, on the new meter is 230,000, which was used to determine, what should have been billed, during the months in question.

Section 9.11 Abatement

Abatements may be made by the Water Commissioners upon the customer's request, provided one of the following reasons is given:

- financial hardship, as evidenced by the customer receiving aid at the time of the abatement;
- fire or disaster;
- to correct a billing error; or
- for such other reason as may be determined by the Board of Water Commissioners.

Customers shall not be prohibited from making an abatement request, nor shall the Water Commissioners be obligated to grant an abatement.
