SELECTMEN'S BUDGET MEETING

Mrs. Kyle opened the meeting at 10:06AM as a continuance from Tuesday's budget session.

Fire Department - 230

Chief Bill Edwards was present. Mr. Manzi explained they removed \$90K from the overtime line in the ambulance revolving fund. The board has not yet taken action on the overtime line in this account. He said \$50K was removed from the equipment lease line. Mr. Manzi said they have budgeted \$590K in the last budget cycle but it has been under budget. He has asked the chief to tow the line due to monetary issues so there is no time off for the firefighters unless they switch shifts. He would ask to amend his number to \$795K it is not what the chief is asking for, but it is an improvement over last year. This is something they will need to address again next year but it's taking steps in the right direction.

Chief Edwards doesn't agree and doesn't account for the increases in the 2020 budget or anything that has to be rolled into 2021. Mrs. Brown feels it is reasonable for this year. Chief Edwards said they will be here again next year to either cut services or break the contract. Under the contract there is no increase to the firefighters, and they have a cap on how much they can carry-over on the time they receive. Chief Edwards said the board will need to make decisions next year as to what they will need to do in order to get past the 2021 budget as this only brings them up to where they were in 2019.

There was discussion on having an overtime "B" account to allow the chief to fill a shift when an employee is injured while on duty or not. Chief disagrees that money would be taken from this account on a yearly basis.

Mr. Manzi said it would increase the bottom line, but the second account would need further restrictions in order to expend from that line. Mr. Khan asked if they could have a report on the police and fire overtime when they receive the monthly expenditure report. Mr. Manzi would recommend \$100K for the second overtime account.

Mrs. Kyle said the planning board lost money when they stopped taking in fees for applications.

The chief is requesting a new line for infectious disease control for \$20K so if the board approves this request the bottom line would be \$5,132,170.

Katie Duffey and Patrick Collins were present. Mr. Collins spoke about the programs being offered to the children. Mr. Manzi said at the direction of the board and to keep with the funding he advised Ms. Duffey to be prepared to discuss the programs that were being offered. Ms. Duffey said she would like to be fiscally prepared to offer the programs they have had for the past 30 years rather than be unprepared. Mr. Manzi said it is a policy decision by the board as to what they are looking at in regard to the budget and programs that can be offered within that budget.

Ms. Duffey said they were on a hiring freeze and they are at about 50%. The baseline is 66% so they are 16% to the good in the recreation center budget. She said they are funning programs now with the afterschool program that begins Monday.

There was discussion on bringing employees back who have been laid-off. There was discussion on the guidelines in order to serve the residents and offer the programs. Mr. Khan said he is not looking for them to jeopardize the guidelines he wants to see those followed for the safety of our residents. Ms. Duffey said the guidelines no matter if they go up or not, they cannot do the same programs without more staff.

The afterschool program has been offered for 2 weeks and only 9 children are signed up. Ms. Duffey said on January 1 they will be open until 9PM. Mrs. Brown asked if the positions that say "new" are for new hires. Ms. Duffey said they are not newly created positions.

There was discussion on the membership fees for the residents of town. Mrs. Kyle said they have asked for an increase in the fee a while ago. Mrs. Brown said she could see increasing the nonresident fee but not the residents as they pay for this department through the taxes. Ms. Duffey doesn't feel increasing the membership fees for residents would be a significant amount of money especially since it is every 5 years.

Line 112 - part time employees - increase to \$47,596 and this would be to hire an employee to disinfect the building. There was discussion on having someone who is already working do this type of disinfecting and is strictly for Covid related. Mr. Khan said they could transfer the maintenance of the recreation center to DPW and it would be run more efficiently. Mr. Khan said in order to make the building safe she has a valid point. He said we have done more cleaning in other buildings and we need to do the same for the recreation center. Ms. Duffey said they are vastly different than a fire and police department as they will have over 100 people every hour in the building on a Saturday and Sunday.

Board took a 5-minute break at 2:53PM.

The board picked up where they left-off discussing line 112 - part time employees and changing it to \$47,596. Mr. Khan suggested they utilize an employee they already have to sanitize the building rather than hiring a new part time position. Deputy Police Chief Gelineau explained that over at the police station they use a contracted agency to clean after hours and it works for them but in his opinion a contracted agency may not be a great idea for recreation as they would have to wait around in between basketball games, etc. Finding a part time employee to do the cleaning would be the better route to go.

Chief Brett Walker and Deputy Chief Kevin Gelineau were present. Chief Walker said back in March he was able to get 2 new patrolmen as the warrant article passed but unfortunately the town budget failed so he was not able to get the 3rd patrolman or dispatcher, so he is asking again this year in the budget for both of those positions. He said he has hired the 2 new

officers and one is at the academy and the other has an offer letter. He has also hired a new lieutenant.

Mr. Khan asked why he doesn't want to have a warrant article for the additional officer and dispatcher. Chief Walker explained his warrant articles tend to fail at town meeting and feels it is more successful in the budget but is open for either.

Mr. Manzi reminded the chief and the selectmen that the town budget needs to pass at town meeting to be able to post these positions. Deputy Chief Gelineau voiced that collectively as a town all departments need to come together and promote the budget as if they are promoting an article.

The increases in the police department budget are mostly due to contractual obligations. Chief Walker would like to add an additional \$115K to line 140 - overtime. He explained he would like to add an additional \$45K to line 442 - patrol fleet units as every 2-3 years they change out the fleet cars and it is now getting more expensive for each one. He would also like to add \$1K to line 621 - public relations education supplies for PR items for the public and children like stickers and badges. He would also like to allocate \$4K to line 745 - K9 new equipment - for food and equipment for Henry and add \$10K to line 812 - training.

The board discussed all of the requests and agreed with Chief Walker to approve the new budget amount with all requested changes.
