On Tuesday, April 13 2021 an inspection was conducted in conjunction with Seabrook Code

Enforcement Lacey Fowler at a permanent structure at 3 Chevy Chase Rd. known as Phantom Fireworks Inc. The inspection found no violations with Seabrook Town Code 162-3, State Fire Code Saf-C 6000, NFPA 1, NFPA 101 and NFPA 1124. The fire suppression system, fire alarm and fire extinguishers are current with inspections. Housekeeping is in order, no debris found inside or outside and all means of egress are clear. This fire inspector finds Phantom Fireworks Inc. to be compliant and recommends renewal of annual license to sell permissible fireworks.
