## **Fire Inspection Report**

This is to confirm that on Wednesday, April 28, 2021 that a fire safety inspection was conducted on a permanent structure located at 287 Lafayette Rd. Seabrook, NH 03874, DBA Atomic Fireworks Inc. (603)474-1900. Also present was Seabrook Code Enforcement Lacey Lou Fowler and Manager Steven J. Carbone 110 Stumpfield Rd. Kensington, NH 03833.

The inspection found no violations with Seabrook Town Code 162-3, NH Fire Code Saf-C 6000, NFPA 1124, NFPA 1 and NFPA 101. Fire suppression system, fire alarm and fire extinguishers were all current with annual inspections. Housekeeping is in order, no debris found inside or out and all means of egress are clear. This Fire Inspector finds Atomic Fireworks Inc. to be compliant and recommends renewal of annual license to sell permissible fireworks.




