# **Fire Inspection Report**

This is to confirm that on Thursday May 27, 2021 that a fire safety inspection was conducted on a permanent structure located at 443 Route 286, Seabrook, NH 03874, DBA Fireworks Over the Border Inc. (603)474-2663. Also present was Seabrook Code Enforcement Lacey Lou Fowler and Manager Antony Rizzo 6001 Pelican Bay Blvd., Apt. 701, Naples, FL 34103.

The inspection found no violations with Seabrook Town Code 162-3, NH Fire Code Saf-C 6000, NFPA 1124, NFPA 1 and NFPA 101. Fire suppression system, fire alarm and fire extinguishers were all current with annual inspections. Housekeeping is in order, no debris found inside or out and all means of egress are clear. This Fire Inspector finds Fireworks Over the Border Inc. to be compliant and recommends renewal of annual license to sell permissible fireworks.


