SECTION 28

AS SHOWN ON GRAVE PLOT DIVISIONS AT HILLSIDE CEMETERY DATED NOVEMBER 24, 2009 BY MILLENNIUM ENGINEERING, INC.

The following restrictions are to apply: One (1) monument or upright stone shall be placed on a 2 or more, side by side, plot lot. Monuments will be no larger than 30 inches wide and must be centered on a 2, side by side, plot lot. Only 1 monument or upright stone shall be placed on a 2 or more, end to end, plot lot. Larger than 30 inch wide monument will be allowed and must be centered on a lot of 3 or more, side by side, plot lot. Larger than a 30 inch wide monument will be allowed and must be centered on a 4, back to back, plot lot. On a lot of 1 plot, only flat grave markers are allowed. A burial space is 48 inches wide and 10 feet long. If any burial space or spaces remain unused and not improved for a period of 50 years, forfeiture procedures may be invoked in accordance with RSA 289:18.
