The above property owner is requesting an abatement/refund of \$133.22 for a after hour water service call fee. The property owner called the police department who in turn gave the information to the on-call operator. The operator returned the homeowners call and they had a lengthy discussion on his water service. The operator offered to meet the homeowner, but he declined as he was getting on a plane. The Water Department incurred a charge by paying the employee per union contract. The homeowner was aware of the policy because he filed for abatement/refund in 2022 for an afterhours service charge which he was denied. The issue was clearly not an emergency, as it could have been handled during the week.

I do not recommend this request.

Dear Mr. Slayton,

I am writing to dispute a water and sewer bill I received on April 21, 2023, 002 48010.

On April 3, I met Randy from the water department to turn the water on at 307 Atlantic Ave., Seabrook. He installed the meter and turned the water on at the street. On Saturday, April 8 I had my plumber turn the water on to the house.

My plumber was unable to fill the toilet fixtures, sinks etc. because the water pressure was so low. Sand had infiltrated all of the lines and clogged the meter, the gears wouldn't turn. At this point I called Jay the Town plumber on call. He suggested I call on Monday and have the meter maintenance department replace the meter to avoid a costly after hours service call. We may have spoken for 4-5 minutes. On April 12 Randy replaced the meter chamber, no problem since then. I did incur additional expenses because my plumber had to return to clear the showerheads, sink aerators etc. Subsequently I received the attached bill for \$133.22, that's an expensive phone call, I m asking you to kindly retract this bill.

Approximately September/October 2022 the main water shut off at the street was bubbling up water and forming a puddle at the end of my driveway. The water department subsequently dug up part of my driveway and replaced the curb stop. This was the only Street excavation done in my area. None of my neighbors had this problem. I believe sand was introduced into the line at that point or when the water was shut off in late October. This is not my fault.

I'm asking you retract this bill.
