Warrant Articles

Mr. Manzi explained the AARPA funding and that the restrictions had been lessened for the smaller communities who could prove loss of revenues during Covid. The town received approximately \$880K. He said the money has to be expended by 2024 and there is no match required. Mr. Manzi stated the articles using AARPA funding does not need to be placed on the warrant as the Selectmen are the agents to expend the funds.

Mr. Starkey said there is an immediate need for the F350. Mr. Manzi stated the AARPA funds cannot be used for previous debt that was undertaken such as a town truck we are already making payments on.

Mr. Starkey said the scale is also an immediate need as it just recently failed an inspection test. Mr. Manzi said he would recommend increasing the funding on this to \$100K. He said if the money is not used by the deadline, then that money is forfeited. The current projects recommended for AARPA funds totals \$790K so any additional funding needed for the projects up to the \$880K can be absorbed. Mr. Manzi feels there is time through the first quarter of 2024 to put in additional projects if there is money remaining.

There was discussion on the roof at the transfer station. The cost for this would be to clean up the roof and then to re-epoxy the current roof, it would not be to replace it. Mr. Manzi said of all the projects using the AARPA funds will need to follow the purchasing policy.

Mr. Eaton asked if money in this article could be used for sidewalks. Mr. Manzi said the article does include the term "sidewalks" in case the Selectmen chose to do so. Mr. Eaton said he would also like to see of this money allocated to parking areas, specifically the fueling station.

Ravi would like to see the list of recommended roads sooner as it would give the public more time to make comments. Mr. Starkey said it would depend on when he gets the state bid as he

piggybacks off of that and the cost is what he bases his recommendations on.

Ms. Carter estimates it will be about \$8,400 to replace. current water heater services the 2 large bathrooms and the showers if they were active.

There was discussion on installing a tankless system and Ms. Carter said she is open to getting a cost. It will be more efficient as it heats on demand.

Mrs. Kyle recommended they put this article on hold until they obtain a quote on the tankless system.

Recreation Bus - \$50K Warrant Article

Ms. Carter explained that having a second bus would allow 28 participants for a program rather than the 14 they currently allow. There is no special license required to drive the bus so any person 18+ can drive it.

There was discussion on renting a bus rather than a purchase and the cost to rent could be factored into the actual cost of the trip. Ms. Carter will get costs for the Selectmen to compare but doesn't feel renting a bus for a 10-week program would be feasible. Mrs. Kyle said they could put a not on the article that the cost is only for the purchase and doesn't include costs to operate.

Multi-Room AC Replacement - \$24K Warrant Article
Ms. Carter explained what the rooms were used for. The quote is
for replacing what they currently have. Mr. Eaton asked if the
quote was for mini splits which would be more efficient and
could also be used as a heat pump.

Mrs. Kyle asked if they could use AARPA funds for this project if it is something that is needed to be replaced so they don't risk the warrant article failing. Mr. Manzi said they could consider using the funds.

Ms. Carter said she would get quotes for the mini-splits and forward them to the town manager. This item will be on hold for further information on the mini-split cost and AARPA funding.

Ravi asked if they could use any of the AARPA funds to fix one or two of the walkways at the beach. Mr. Manzi said there is nothing restricting the Selectmen for that function.

Mr. Eaton said his priority is in the departments first and then if there is money remaining, they could look at putting some funds to that area. Ravi said he would like to earmark a portion of this money for the walkways as they don't have a

department for beach walkways, and it is a safety concern. Mr. Eaton said once they have solid numbers for the items that are a priority, he would be more comfortable with allocating the funds. There was further discussion between Mr. Eaton and Ravi in this area.

Mrs. Kyle said they need further discussion on the walkways at the beach. She said one walkway was completely destroyed by the contractor. Ravi agrees it requires further discussion but that shouldn't deter them for putting money aside to repair some walkways. Mrs. Kyle said if there is overage of funds, they could look at repairing some walkways. Ravi stated they should put the money aside and treat it as just as important as the other recommendations.
