There was a discussion on the Andover Street walkway. Mr. Manzi gave an update as to where they are with the DES. He has not followed up with the planting, but the commitment is still there.

Ravi said spring is the time to do the planting. He feels they should schedule some time so when the permit is available, they can begin work. If they don't schedule time, they may not be available to do this work until fall.

Mr. Eaton said he would like to see all construction complete before they begin to put vegetation in the ground. He said they would be using construction vehicles, and they may need to wait until fall to do the planting.

Mrs. Kyle said if there were volunteers, she would like them to sign a disclaimer that if they were to be injured, they would not sue the town.

Mr. Eaton said a tree was removed in this area and some residents are concerned. Mr. Manzi said he is not sure who removed it, but he is aware that it was taken down. Mrs. Kyle commented she was told it was a worker who was instructed to take it down and then dig out the stump. She feels a letter should be sent to the owners of the property who are doing work in this area. Mr. Manzi said he will try and get this resolved.

Doris Sweet - Atlantic Avenue - went out to the property when the tree was removed and spoke to the worker. The worker indicated it was the property owner on the south side.

Hello,

We wanted to thank the voters that came out and supported the town, but more specifically the voters that supported our fire department at the polls last tuesday. This was the largest voter turnout for the town vote that I can remember seeing. We really appreciate people making sure they made the time and effort to get to the polls to cast a vote, once again thank you.

We were able to see our Capital Reserve Fund Article pass which will maintain the funding of the air packs and turn out gear we wear to fight fires. Unfortunately the 8 new firefighters did not pass. We are, however, excited for the study on our manpower issues to begin once a company is selected. The study we hope will provide more information for the public to see and gain a better understanding of what is required to provide the services we provide to this community in a safe manner for both the community and our fire department.

We would like to congratulate Theresa Kyle on her re-election to the board of selectmen, she has been a great supporter of our department and a great partner in moving this town and our department forward. We are looking forward to the next three years working together.
