Mr. Eaton opened the meeting at 9:40AM.

John Starkey was present for all of the public works departmental budgets.

HIGHWAY - 310

Mr. Starkey said most of the increase in the salt line. This line has been over-expended in 2024.

Mr. Eaton would like to cut line 410 - electricity by 10% due to the infinity lighting program that will be implemented. Mr. Manzi explained that the immediate savings would be used towards the purchase of the equipment that is needed for the program.

Mr. Starkey explained that he is behind in terms of this year's budget due to understaffing in administration. Mr. Manzi explained it is a bottom-line budget so where one line is over, they have to save money in other lines.

STORMWATER - 320

Mr. Starkey explained what the stormwater budget is used for and said that it is an unfunded federal mandate. There are other Seacoast communities that have to abide by these same mandates. The other contract service is mostly for professional engineers.

Mr. Eaton asked about Cains Brook and if the state has been contacted for assistance where it runs under their road. Mr. Starkey informed the board they are in constant contact.

RUBBISH - 330

Mr. Starkey explained why the full-time line decreased due to an employee who had long tenure with the town and was filled with an employee with a lower pay.

There was discussion on the part-time line and that the back of the rubbish truck is filled with these part-time employees. The double runs at the beach contribute to this increase as well. In regards to the beach walkways and Mr. Starkey said the union employees would work on this project if it became a priority.

Mr. Eaton suggested that at some point they should look at making the positions for the back of the rubbish truck full-time positions. He wants to be able to retain these workers and if we don't have this then it becomes a future problem.

Ravi said they could look at other alternatives for these parttime employees to give them incentives without spending too much taxpayer money.

Mrs. Kyle said they can make more money part-time at Wal-Mart than working for the town. Ravi said this is a good conversation to have at another meeting and would like to add to the follow up list.

Mr. Starkey said he and the town manager do not agree on the full-time line increase. He said there is a need for a full-time position in the cemeteries. Mr. Manzi explained this would be for a third full-time secretary. Mr. Eaton feels that the same employees should be able to do the work in both the parks and cemetery. Mr. Starkey explained why he needs 3 full-time positions in administration.

There was discussion on looking at a projection for growth in the departments. Mr. Starkey asked if it would be palatable to fund the position for half of the year. Mr. Eaton and Ravi would like to stay with the recommendation of the town manager. Mrs. Kyle disagrees that with a town that has tripled in size and the person who was doing the work was out in the field helping the citizens.

Ravi said it needs a clear reason to the benefit of the community so the voters will vote in favor. Mr. Eaton suggested stating that the showers would be removed as they are under-utilized and will create more space for programs, etc.

Article 19 - read by Ravi to repair and renovate the kitchen area. Ravi would like to see the note amended to reflect the need to the taxpayers. Mrs. Kyle doesn't feel this should be a warrant article as it is a necessity for town functions. asked if there was money available such as AARPA funds. Eaton asked what was left in AARPA and then suggested going to the big home improvement stores to see if they will sponsor the project for the rest. Mr. Manzi said there is about \$30-35K in AARPA funds. The board agreed to remove this as a warrant article and come up with funding for the project.

Michele Knowles was present for her budget.

TAX COLLECTOR - 150

Ms. Knowles said she would like to increase the rate for the part-time employee who currently makes \$16.74 per hour and would like to raise it to \$18.50 per hour. There was a long discussion on increasing the rate by \$1.00/hour and \$2.00/hour for all part-time employees.
