

Upon the petition of the undersigned legal voters of the Town; "To see if the Town will vote to modify the Elderly and Disabled exemptions from property tax in the Town of Seabrook, New Hampshire, beginning with the 2025 tax year, based on assessed value, for qualified taxpayers, to be as follows; Elderly exemption under RSA 72:39-b, Elderly person 65-74 \$230,000 off assessed value, Elderly person age 75-79 \$260,000 off of the assessed value, Elderly person age 80 years or older \$310,000 off of the assessed value. Disabled exemption under RSA 72:37-b, \$230,000 off of the assessed value. To qualify for the Elderly exemption the person must have been a New Hampshire resident for 3 consecutive years. (person must have been a New Hampshire resident for 5 consecutive years for Disabled exemption) preceding April 1st of the year of application, own real estate individually or jointly, or if the real estate is owned by such person's spouse, they must have been married for at least five years for both Elderly and Disabled exemptions. In addition, the taxpayer must have gross income (including Social Security) of not more than \$48,000, if single, or married, a combined gross income of not more than \$71,000 (including Social Security). Income limitations are based upon earnings during the prior calendar year. Total assets for both Elderly and Disabled exemptions may not exceed \$250,000 whether married or single; excluding the value of person's actual residence and the land upon which it is located."
